Item No.1(b)(i):

The proposal of M.A. Rangoonwala Dental College, Pune (BDS0005) in respect of B.D.S & M.D.S courses for approval of fees for the academic year 2024-2025.

"Discussed.

While examining the proposal it is noticed that the Institute has not furnished the Form No. 16 in prescribed proforma uploaded from the website of the Income Tax Department (i.e. traces of form no. 16) in respect of number of staff members inspite of direction given. It was decided to provide last chance to the Institute/College to submit the Form No. 16 uploaded from the site of Income Tax Department. Failure to submit the Form No. 16 of the employees in respect of direction already given the Authority will be constrained to draw appropriate inference and disallow the expenditure.

The Institute be directed to comply the direction within three days. List after compliance".

Item No.1(b)(ii):

The proposal of Aditya Dental College, Beed (BDS0023) in respect of B.D.S & M.D.S courses for approval of fees for the academic year 2024-2025.

"Discussed.

While scrutinizing the proposal it is noticed that Institute has not submitted the statement in prescribed proforma the information about the fees collected from the students in the academic year 2023-2024 under N.R.I & Institutional Quota. So also, the Institute has not submitted Form No. 16, in prescribed format uploaded from the website of Income Tax Department (i.e. traces of form no. 16). The fees reconciliation collection reflects the excess collection of rupees by the Institute/College.

It was decided to direct the Principal of the College to submit the documents and information within three days. Failure to comply appropriate inference will be drawn on account of non-compliance of the direction & fees will be decided accordingly.

Item No.1(b)(iii): The proposal of Dr. Rajesh Ramdasji Kambe Dental College & Hospital, Akola (BDS0026) in respect of B.D.S & M.D.S courses for approval of fees for the academic year 2024-2025.

"Discussed.

While scrutinizing the proposal it was noticed that the Institute has shown more than Rs. 2 crores as provision i.e. the salary unpaid in the Audited Financial Statement of the financial year 2022-2023. The Institute has not submitted the Form No. A1 & A2 as per the revised form issued by the Authority with the proposal submitted for academic year 2024-2025. The form no. A1 & A2 in old format has been submitted. So also the Institute has not submitted the information in prescribed proforma of the fees collected from the students admitted under Institutional & N.R.I Quota during the academic year 2023-2024. Hence, the Principal of the Institute be directed to provide the information in the prescribed proforma about the fees collected from the students admitted under Institutional & N.R.I Quota in the academic year 2023-2024 as well as revised A1 & A2 form duly filed in and signed and attested by the Chartered Accountant as well as the Principal of the Institute. The compliance be made within three days.

The Institute be informed that non-compliance of the direction the Authority will be constrained to draw appropriate inference & decide the proposal by making disallowance of expenditure.
